Subject:	Discussion with reference to reviewing the result forms of some of the polling centers before publishing and announcing them.

Based on the ordinance of article 156 of the Constitution of the Islamic Republic of Afghanistan,

The IEC decided as follows:

1. Owing to clear election fraud (crossing out in the result forms, appropriating a great number of votes in favor of some specific candidates, non-certification and non-presence of signatures of the assigned agents and the reports received on the electoral process with respect to the problems in polling process) the votes cast at polling stations and centers listed bellow are excluded from counting and announced as invalidated votes:
 - Polling center (1015356) of Ningrahar province due to appropriation of votes in favor of some specific candidates by taking note of election fraud evidences,
 - Polling center (1015390) of Ningrahar province due to appropriation of votes in favor of some specific candidates by taking note of election fraud evidences,
 - nmkn polling center (0704049) of Paktika province due to appropriation of votes in favor of some specific candidates by taking note of election fraud evidences,
 - Polling center (0708111) of Paktika province due to appropriation of votes in favor of some specific candidates by taking note of election fraud evidences,
 - Polling center (0707096) of Paktika province due to appropriation of votes in favor of some specific candidates by taking note of election fraud evidences,
 - Polling center (1602061) of Baghlan province due to the reports received on E-day regarding the non-voting process in the area,
 - Polling center (1602054) of Baghlan province due to the reports received on E-day regarding the non-voting process in the area,
 - Polling center (1602050) of Baghlan province due to the reports received on E-day regarding the non-voting process in the area,

- Polling center (1706143) of Kundoz province due to appropriation of votes in favor of some specific candidates by taking note of election fraud evidences,
- Polling station (03) of polling center (1702073) of Kundoz province due to appropriation of votes in favor of some specific candidates by taking note of election fraud evidences, and
- Polling center (1805056) due to appropriation of votes in favor of some specific candidates by taking note of election fraud evidences.

The case must be referred to the ECC. Moreover, complete ID of the polling stations' chairpersons of the centers abovementioned must be prepared and sent to the ECC and Attorney General Office for the purpose of further prosecution. Additionally, the candidates in favor of whom the violations and election frauds took place must be introduced as persons who made the infringements, violations and election frauds to the ECC.
