Subject:	Reviewing the result forms of some of the polling centers before announcing and publishing them

Based on ordinance of article 156 of the Constitution of the Islamic Republic of Afghanistan, the IEC, decided as follows:

1. Votes cast at the polling stations and centers listed bellow due to clear signs of election fraud (cross outs on the result forms, appropriation of high number of votes in favor of some candidates, non-certification and non-presence of the signs of candidates' agents, disproportion in the votes of polling stations and the obtained reports on E-day with respect to the problems of electoral process) are to be excluded from counting and announced as invalidated votes:
