Subject:	Reviewing the result forms of some of the polling centers before publishing and announcing them

Based on ordinance of article 156 of the Constitution of the Islamic Republic of Afghanistan, the IEC, decided as follows:

1. All votes cast at the stations and centers listed bellow owing to clear signs of election frauds (cross outs on the result forms, using the whitener on the result forms, appropriating high number of votes in favor of some specific candidates, using more than 600 ballots in one polling station, non-certification and non-existence of candidate agents' signs and the received reports from the IEC Provincial Offices, DFCs, candidates, candidates' agents and observers about polling process problems due to security, non-holding of elections, irregularities at polling centers and ballot stuffing by the powerful figures in the region) are excluded from count and shall be announced as invalidated.
 - Polling center (1004115) of Nangrahar due to fight and insecurity at the polling center and stealing the related election materials,
 - Polling center (1003119) of Nangrahar due to an explosion at the polling center and non-arrival of the center's related results,
 - Polling center (1406085) of Badakhshan due to burning the electoral materials by people on E-day,
 - Polling center (1414175) of Badakhshan due to non-participation of voters and non-arrival of the results,
 - Polling center (1427261) of Badakhshan due to non-participation of voters and non-arrival of the results,

- Polling center (1601012) of Baghlan due to non-count of votes,
- Polling center (2101028) of Sar-e-Pol due to loss of TEB,
- Polling center (2103051) of Sar-e-Pol due to fight on E-day in the center and non-arrival of the results,
- Polling center (2406443) of Hirat due to non-participation of voters and non-arrival of the results,
- Polling center (2412315) of Hirat due to non-arrival of the result forms,
