Subject:	Introducing the Successor of Mohammad Anwar Akbari previous representative of Daikundi in the Parliament and Issuing Accreditation Letters to Applicant Institutions.

Based on Article (۱۳) of Structural law of IEC and IECC and Pursuant to provisions of Article (۱۴.۱.۱۳) of the mentioned law and based on Articles (۲۴.۳ and ۵۵) of the Electoral Law of Islamic Republic of Afghanistan, the Independent Election Commission decided that:

۱. Based on the prepared list of ۲۰۱۰ Parliamentary Elections results by the Commission, previous senator Mr. Sayed Mohammad Daud Nasiry shall be introduced as the representative of Daikundy in the Parliament of Islamic Republic of Afghanistan instead of Mohammad Noor Akbari who has resigned from his position in the Parliament because of his participation in ۲۰۱۴ Presidential Elections.
۲. Accreditation letters shall be issued to the following Institutions which have submitted the required documents to the Commission for receiving Accreditation letters and have signed the related Code of Conducts,:
