In consideration of the authorities delegated in article 79 and according to paragraph 3 of article 12 of the law of structure and authorities of IEC and ICC and paragraph 3 of article 31 and article 55 of the election law, the Commission decided that:

1. Regulation on participation of candidate agents and observers in the open sessions of the Commission attached to this decision is approved.
2. Mr. Mohammad Daud son of Nik Nazar as successor member instead of Mohammad Anwar is introduced to the Helmand provincial council.
3. For the following organizations who have submitted required document to the Commission according to regulations and have signed the code of conduct, Accreditation letters shall be issued as follows:
