Taking note of Article 13 of the IEC and IECC Structural Law, the IEC decided as follows:

1. In previous elections, a copy of the result form was given to a candidate agent based on lottery and another copy was hung in the polling station. In 2014 presidential run-off election, both copies of the mentioned result form in vote counting center shall be submitted to both candidates' agents.
2. In those female polling stations where based on various reasons, the Commission could not succeed to recruit female staff, instead of them the elders and tribal elders shall be hired as electoral temporary staff members. In case there are no female candidates' agents, respectable candidates may hire the elders and assign them at mentioned polling stations for monitoring purpose. Additionally, the candidates of presidential run-off election are to be provided with a list of the mentioned polling stations.
3. In National Tally Center (NTC), two committees must be established that will be comprising of heads of the IECS departments led by Chief of Operation-deputy to CEO:

- NTC management committee, members of which will be head of training & capacity building department, head of planning & procedures department, head of legal department, head of external relations department, head of ICT department and head of logistic department.
- Electoral sensitive materials intake committee, members of which will be head of field operation department, head of logistic department and head of public outreach department.
