## Decision of the Independent Election Commission

Decision Number:	45-2010
Subject:	Suspicious result forms of polling stations of some polling centers.

Pursuant to article (156) of the Afghan Constitution

### **The Independent Election Commission decided that:**

1. Votes of polling stations of some polling centers or candidates written bellow have been considered as invalid and the ECC is notified of the issue:
  - Votes of candidate number (15) in stations (1 and 2) and votes of candidate number (14) in station (3) of center (2504048) in Farah province must be invalidated.
  - Votes of candidate number (3) in stations (01 and 02) of center (0707288) in Paktika province must be invalidated.
2. Votes of candidates or stations of the following polling centers must be corrected:
  - Votes of candidate number (58) in station (01) of center (12010130) in Laghman province must corrected to (41) considering row of letters.
  - Votes of candidate number (109) in Ningarhar province must be corrected according to the copy of the result form in the ballot box if it is not tampered with. If there is any problem with the form, the votes inside the ballot box must be recounted.
  - Votes of candidate number (30) in Wardak province must be corrected according to the copy of the result form in the ballot box if it is not tampered with. If there is any problem with the form, the votes inside the ballot box must be recounted.

- Votes of candidate number (36) in station (03) of center (2205104) in Faryab province must be corrected to (280).
  - Votes of candidate number (15) in station (04) of center (1407096) in Badakhshan province must be corrected to (15).
3. Votes of polling stations of the following polling centers must be inspected and recounted in presence of representative of the ECC as well as agents.
- Votes of stations ( 01 and 02) of center ( 2416422) in Herat province
  - Votes of stations ( 01 and 02) of center ( 0408120) in Wardak province
  - Votes of stations (01 and 09) of center ( 0507074) in Logar province
  - Votes of stations ( 01, 02 and 03) of center ( 0408112) in Wardak province
  - Votes of stations ( 01, 02, and 03) of center ( 0409158) in Wardak province
  - Votes of stations ( 01, 02, and 03) of center ( 2101015) in Sar-e-Pol province
  - Votes of stations ( 01, 02, and 03) of center ( 2204070) in Faryab province
  - Votes of stations ( 01, 02, and 03) of center (0301035) and stations (01 and 02) of center (0306095) in Parwan province
  - Votes of stations (03 and 05) of center (1704117) in Kunduz province
  - Votes of candidate number (38) in station (01) of center ( 2404441) in Herat province
  - Votes of stations (01, 02, and 03) of center (2404147) in Herat province
4. Votes of the following polling stations must be processed and entered into the system:
- Votes of stations ( 01 and 02) of center (0403025) in Wardak province
  - Votes of stations ( 01 and 02) of center ( 2202201) and stations (01, 02, and 03) of center (2203062) in Faryab province
  - Votes of stations ( 01 and 02) of center (1414176) in Badakhshan province
  - Votes of stations ( 01, 02, and 03) of center (1701021) in Kunduz province, and
  - Result forms of station (02) of center (1401021) and (02) of center (1401009) in Badakhshan province have been considered valid and must be processed and entered into the system.
