Pursuant to article (156) of the Afghan Constitution

The Independent Election Commission decided that:

1. Ballots of the following stations and centers should be excluded from counting and be announced invalid due to existence of signs of evident fraud (non-existence of scotch tape on the result forms in the first stage, existence of cross outs on the result forms, allocating high number of votes to specific candidates, and No-certification and signatures of Agents)

The ECC should be notified of the issue. Meanwhile, the chairpersons' identities of the abovementioned stations should be prepared and sent to the Attorney General Office to be prosecuted, yet those candidates in favor of whom the frauds had been committed, should be introduced to the ECC as violators and fraudulent persons.
