## Decision of the Independent Election Commission

Decision Number: 1389 – 80

Subject:

- ECC's request on inspection and verification of the ballot boxes
- Verification of 11 polling centers of Gero district, situated in Ghanzni province and 4 polling centers of Dahna Ghorī district, situated in Sur-e-Pul province
- Issuance of accreditation cards to Hezb Wadat Islami Afghanistan

Based on ordinance of article 156 of the Constitution of the Islamic Republic of Afghanistan, the IEC, decided as follows:

1. Votes of polling stations and centers due to clear indication of election frauds (cross outs on the result forms, appropriating high number of votes in favor of some specific candidates, non-certification and non-presence of candidates' agents, disproportion in the votes of polling stations and the reports obtained on E-day with respect to the problems during the electoral process) were excluded from counting and announced as invalidated.
  - Polling center (0704057) of Paktika due to cross outs on the result forms, evident fraud in votes, disproportion in votes and non-certification of PSC and candidates' agents;
  - Polling center (0704059) of Paktika due to cross outs on the result forms, evident fraud in votes, disproportion in votes and non-certification of PSC and candidates' agents;

- Polling center (1704114) of Kundoz due to division of votes between some specific candidates in all polling stations and non-existence of signs of conducting elections in this center;
- Polling center (0408118) of Maidan Wardak due to non-certification of the PSC and candidates' agents and appropriation of votes in favor of one specific candidate;
- Polling center (0408119) of Maidan Wardak due to non-certification of the PSC and candidates' agents and appropriation of votes in favor one specific candidate in one center;
- Polling center (0408113) of Maidan Wardak due to cross outs and appropriation of votes in favor of some specific candidates;
- Polling center (3101037) of Ghor due to cross outs on the result forms and evident fraud in votes in favor of some specific candidates and disproportion in votes;
- Polling station (02) of center (1915317) of Balkh due to appropriation of votes in the station in favor of one specific candidate;
- Polling center (1402031) of Badakhshan due to non-existence of result forms, non-certification of the PSC and candidates' agents and non-existence of the stamp;
- Polling center (1427265) of Badakhshan due to appropriation of evident fraud votes in favor of one specific candidate;
- Polling center (2004061) of Jozjan due to appropriation of votes more than 90 % in favor of one specific candidate and the obtained reports on E-day based on stuffing the ballot boxes;
- Polling center (0405071) of Maidan Wardak due to appropriation of more than 90% votes in favor of some specific candidates;
- Polling station (01) of center (1706174) of Kundoz due to evident fraud signs on the result form in favor one specific candidate;
- Polling station (02) of center (2509135) of Farah due to evident fraud signs on the result form in favor of one specific candidate;
- Polling center (1910207) related to Kuchis of Balkh due to use of ink remover and recording of high number of votes in favor of one specific candidate out of the space provided on the result form;
- Polling center (1805092) of Samangan due to division of votes between some specific candidates;
- Polling station (03) of center (2105096) of Sar-e-Pol due to division of votes between some specific candidates in all polling stations;
- Polling center (1115119) of Kundoz due to non-certification of the PSC and non-existence of the candidates' agents and stamp on the result form and appropriation of votes in favor of one specific candidate;
- Polling center (2410458) of Hirat due to use of more than 700 votes in each of the polling stations;
- Polling station (02) of center (2504067) of Farah due to no use of scotch tape on the result form, cross outs and appropriation of votes in favor of one specific candidate.

Regarding the issue, the ECC is to be informed; moreover, a list of complete identification of the PSCs of the centers above mentioned is to be prepared and for the purpose of prosecution, they shall be introduced to the ECC and Attorney General Office

and with regards to the candidates in favor of whom the frauds have taken place, a complaint is to be laid with the ECC protesting them as fraudulent and offenders.

2. Votes cast at the centers listed bellow, owing to being dubious, they shall be inspected and recounted in the presence of the ECC representatives and candidates' agents.
