Subject:	Reviewing result forms of a number of polling centers before publishing and announcing them.

Pursuant to article (156) of the Afghan Constitution

The Independent Election Commission decided that:

1. Ballots of the following stations and centers should be excluded from counting and be announced invalid due to existence of signs of evident fraud (existence of cross outs on the result forms, allocating high number of votes to specific candidates, No-certification and signatures of Agents, disproportion in votes of stations and reports received on the Election Day regarding problems with the polling process)
 - Center (206086) in Kapisa province due to evident fraud on votes, disproportion of votes, non-certification of PSC, and agents
 - Center (2812217) in Kandahar province due to non-certification of PSC, agents, no- existence of official seal on forms, cross outs, and disproportion of votes
 - Center (0707101) in Paktika province due to non-certification of PSC, agents, no- existence of official seal on forms, cross outs, and disproportion of votes and allocation of votes in favor of a specific candidate
 - Center (2704095) in Helmand province due to disproportion of votes and allocation of votes in favor of a single candidate
 - Center (2205110) in Faryab province due to allocation of votes in favor of a specific candidate
 - Center (0707085) in Paktika province due to non-certification of PSC and agents, non-existence of official seal on forms, cross outs, disproportion of stations'

 - Center (2407201) in Herat province due to cross outs and reports on electoral irregularities on E-Day at the center and disproportion among votes of stations
 - Center (2304079) in Badghis province due to cross outs on result forms and disproportion among votes of stations
 - Center (0715228) in Paktika province due to cross outs on result forms and recording votes in favor of a specific candidate
 - Center (0711166) in Paktika province due to non-certification of PSC and agents, non-existence of official seal on forms, cross outs, disproportion of votes and allocation of votes in favor of a specific candidate
 - Center (2304080) in Badghis province due to cross outs and reports of electoral irregularities at the center

The Electoral Complaint Commission must be notified of this issue. Meanwhile, the chairpersons' identities of the abovementioned stations must be prepared and sent to the Attorney General Office to be prosecuted and complaints must be filed with the ECC against those candidates in favor of whom the frauds had been committed, as violators and fraudulent persons.
