Pursuant to provisions of Article (۲۴.۳) of the Electoral Law of Islamic Republic of Afghanistan, Independent Election Commission decided that:

۱. Based on the list prepared by the Commission in accordance with ۲۰۱۰ Parliamentary Elections results, each (Mr. Qudratullah Sahak, Haji Mehdawi, Abdul Qadar, Haji Watan Dost and Alhaj Zmary Padkhwab) shall be introduced as representatives of Kabul in the Parliament of Islamic Republic of Afghanistan instead of (Mr. Abdul Rab Rasool Sayaf, Sayed Husain Alami Balkhi, Ibrahim Qasemi and Sayed Husain Anwari) who have resigned from their positions in the Parliament because of their participation in ۲۰۱۴ presidential Elections.
۲. Mr. Sayed Ishaq Gailani previous representative of Paktika Province in the Parliament has resigned from his position in the Parliament, instead Mr. Haji Abdul Qadeer shall be introduced to the Parliament as representative of Paktika in the Parliament.
۳. (Mr. Shah Abdul Ahad Afzali) previous representative of Badakhshan Province in the Parliament has resigned from his position in the Parliament, instead Mr. Abdul Wali Niazi shall be introduced to the Parliament as representative of Paktika in the Parliament.
