Decision of Independent Election Commission

Number of Decision:	۱۳۹۲-۴۰
Subject:	regulation on addressing media complaints, introducing successors to provincial council members of Ghazni and Faryab who resigned, holding election of the administrative boards of provincial councils and issuing accreditation letters.

The independent election commission decided that:

۱. According to paragraph ۵ of article ۶۱ of election law, the regulation on addressing media violations during election period is approved.
۲. According to paragraph ۱ of article ۷۲ of election law, the administrative board of fourth year of provincial councils (until the new provincial councils start functioning) shall continue their duties.
۳. According to paragraph ۳ of article ۳۱ of election law, the membership of Nawroz Ali instead of Azizullah Poya and Afrefullah Wahidi instead of Sayed Obaidullah at Ghazni provincial council and membership of Mohammad Taher Rahmani instead of Mohammad Ibrahim Timans at Faryab provincial council is approved.
۴. For the following organizations who have presented required documents to the commission according to the regulations and have signed the code of conduct, the accreditation letters shall be issued as follow:
 - a. Accreditation Letter to Observe

- ii. Afghanistan youth cultural and scientific organization
- iii. Afghanistan Electoral Research Organization
- b. Accreditation Letter to Monitor
 - i. Afghanistan Liberalist Party

- c. Accreditation Letter to Report
 - i. Afghan Voice News Agency
 - ii. Safir Television
 - iii. Aryana Television
 - iv. Third Eye Photojournalism Center
 - v. Ranna Limited LLC
 - vi. Voice of American (VoA)
