



Decision of the Independent Election Commission

Subject:	Staff of those polling stations where negligence and violation have been committed

According to the provisions of article 98 of the Election Law and pursuant to the Decision of leadership of this Commission dated 7 Meezan 1398 [September 29, 2019],

the Independent Election Commission decided that:

The IEC Secretariat has the duty to prepare and send to the Electoral Complaints Commission by Saturday, 28 Aqrab of the current year [November 16, 2019] the list of all those polling staff who somehow have committed the below negligence and violation during elections. Such staff shall not participate in the audit and recount process:

1. Those polling station chairpersons who were responsible for signing and stamping of the result form, correct writing of votes of candidates without alteration on the respective result form, however, they have not carried out their duties properly and if the respective polling stations have been referred to audit and recount due to this.
2. The District Electoral Officer (DEO) and Deputy DEO, polling center (PC) manager, polling station (PS) chairperson and BVV operators where polling has taken place without biometrics in their polling stations, who have not captured biometrics properly or who have not filled the digital result form or who have filled it incorrectly and/or have not taken photo of the result form.
3. The DEO and DDEO, PC Manager, PS Chairperson and BVV operator who have lost the BVV device or the microSD Card related to their polling station or if the devices have not arrived at the HQ, or electoral materials have been taken from them coercively and they have not reported it, and/or if there is discrepancy between the votes recorded on the result forms and the data recorded in the BVV devices of the respective polling station.

4. The provincial electoral officers (PEOs) who have not presented at all or have presented not in due time the report on negligence, violations and electoral crimes within their jurisdiction and/or who were somehow involved in negligence, violations and other instances.
